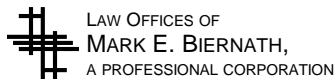

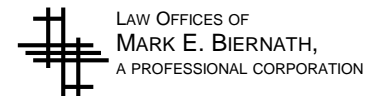

Benefits of Special Needs Planning

Individuals with special needs require specific planning tools. If any of your heirs or beneficiaries have special needs due to a disability, without careful planning any gift or inheritance left to them can cause them to lose important government benefits, or leave them exposed to people who will take their assets.

Without proper advanced planning, even a small inheritance (anything over \$2000) left to your child can have dire consequences. Your child can be disqualified for SSI or Medicaid until they have spent all the money and may have to wait to re-qualify. Thus, the inheritance you intended to benefit your child may actually hurt them. With proper advanced planning you can prevent this outcome, as well as designate someone to watch over your child's best interests. In Georgia, the law allows you to protect assets while providing for an individual with special needs. You can create a Special Needs Trust, also known as a Supplemental Needs Trust. This third party settled trust must contain specific language to protect the assets in the Trust from the claims of creditors and government agencies, while protecting the individual's entitlement to public benefits.

Public benefits only provide a subsistence level of care, special needs planning allows you to provide additional life enhancing benefits which would otherwise disqualify an individual from public benefits. Through special needs planning you can provide for:

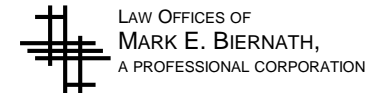
